## 2019 TAX DEADLINE EXTENDED



Due to the Coronavirus, the deadline for *filing* your 2019 federal tax return has been extended from April 15, 2020 to July 15, 2020.

You may still file a six-month extension on your federal tax return but the IRS is urging those who are expecting refunds to go ahead and file their returns so they can begin processing those returns.

You can access your 1099-R from your myERF account by going to ERF's website, www. dallaserf.org, and clicking login to sign in or register if you do not have an account setup.

This extension does not apply to State tax returns, any extensions will be given by the individual state; for example, California has extended their State filing deadline to June 15, 2020. If you are filing a state income tax return, refer to your state's website for information on deadlines.

### **2020 TRUSTEE ELECTION**

## CHOOSE YOUR TRUSTEE, every VOTE COUNTS!

The Employees' Retirement Fund (ERF) is governed by a seven member board of trustees, three of whom are elected by current, active employees of the City who are contributing to the pension fund.

Election and candidate forum dates will be released on our website, www.dallaserf.org, through email and on Facebook @ DallasERF.

#### WHAT IT MEANS TO BE AN ERF TRUSTEE

The seven member Board of Trustees is responsible for administering the Retirement Fund in accordance with the Dallas City Code, Chapter 40A. Three of the seven trustees are elected by the membership, three are appointed by the City Council and the seventh member is the City Auditor, ex officio.

As fiduciaries, each of the Trustee's decisions must be guided by the obligation to administer the Fund for the exclusive benefit of the members, retirees and beneficiaries. It is necessary for trustees to become knowledgeable in areas of investments, management, actuarial policy and pension administration.

#### **HOW TO PLACE YOUR VOTE**

Voting is quick and easy; you can either call in your vote or vote online. The election vendor, Votem, will mail you your ballot instructions. It takes less than a minute to place your vote. The web address and further instructions for voting will be on your ballot to make it as easy as possible for you to participate in the election.

If you have any problems voting, call Votem at 1-888-492-4763; you must have your ballot with you when you call.
