Your Monthly Paystubs & 1099-R Forms are now available in myERF

myERF: YOUR RETIREMENT HOME

When you retired, your myERF experience changed, the portal now provides your monthly pension paystubs, annual 1099-R statements and links to resources such as your Fidelity Accounts, AARP and DCREA.

WHAT DO I NEED TO DO TO CREATE AN ACCOUNT?

To create your myERF account, you will need to register through the ERF website, follow these steps to create an account:

- 1. Go to www.dallaserf.org.** Click register in the top right corner of your screen.
- 2. Choose 'Retiree and Beneficiary Registration.'** Click the blue button.
- 3. Complete the Registration Form.**

- Your account number is on your monthly paystub below the deposit date.
- We suggest that your password contain upper and lowercase letters, numbers and a special character.
- Select three different security questions and answers.
- Check the Accept Terms & Conditions of Use box and click the green create new account button.

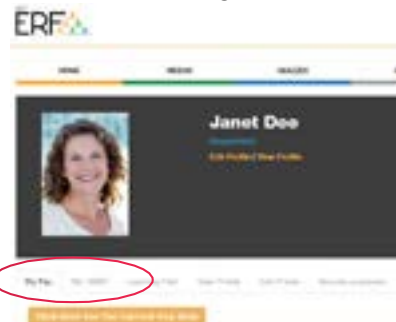
HOW DO I ACCESS MY MONTHLY PAYSTUBS & 1099-R STATEMENTS

You can access your monthly paystubs and 1099-R statement from your myERF profile page by selecting myPay for your paystubs and the 1099-R tab for your statements. You can also choose to continue to receive your 1099-R statements by mail or you can go paperless and access them only through myERF:

- 1. Set your 1099-R mailing preferences.** ERF offers you the option to opt out of receiving mailed 1099-R statements.

- By opting out of mailed statements, you aid the green Dallas environmental initiative and help ERF reduce costs.
- Opt out of mailed 1099-R statements on your profile page in myERF. Login to myERF, locate and submit the 1099-R opt out authorization.

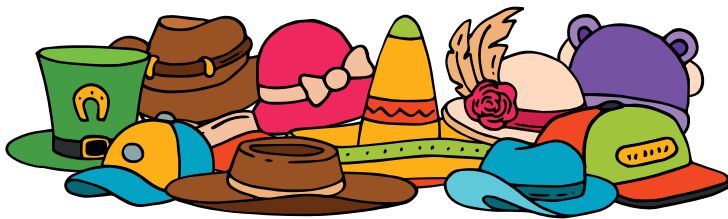

TRANSITIONING TO MEDICARE AFTER 65

If you or your spouse are currently enrolled in a City of Dallas health insurance plan and are within three months of your 65th birthday, you are eligible to sign up for Medicare and enroll in one of the City's sponsored Medicare supplement plans.

You can apply for Medicare online or any local Social Security office. For additional information or to find an office near you, visit www.socialsecurity.gov or call 1-800-772-1213.

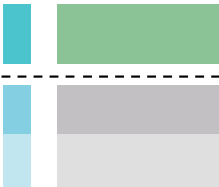
